<u>Description</u>: The project will provide a Consolidated Strategic Satellite Communications (SATCOM) Earth Station and a Technical Control Facility (TCF) to replace the existing SATCOM/TCF facilities, in support of the Joint Chiefs of Staff command, control, communications, and intelligence requirements for the Far East Area of Responsibility. The project will include the SATCOM/TCF facility, a small standard design battalion headquarters with classrooms, a Network Enterprise Center, standby generators, and associated supporting facilities.

Justification: This reprogramming is based on the contractor's proposal, which is higher than anticipated, and includes the full scope for the project. The project cost increase is attributable to several factors. Market Surveys indicate that many qualified prime contractors throughout Japan are already occupied with existing or anticipated work associated with rebuilding the country's infrastructure after the tsunami of 2011 and work associated with the 2020 Summer Olympics. This has resulted in the increased cost of construction material, equipment shortages, and a shrinking pool of available prime contractors that are able to obtain the required bonding capacity for projects of this magnitude. This limited availability also extends to the subcontractors that prime contractors rely upon to complete the construction projects. As a result, prime contractors are compelled to submit higher bids to accommodate their increased risk because of the lack of firm prices received from their subcontractors. The inherent risk on this project is already higher because of the long construction period, six and a half years, which will accommodate the phasing of construction, outfitting of the facilities, and demolition such that there is no interruption of the mission.

<u>Description</u>: This project will construct the first phase of the Army Aviation Support Facility (AASF) at Kapolei, HI. The AASF will provide modern facilities for aircraft maintenance personnel to perform the necessary tasks to maintain the unit's readiness posture. The project includes adequate space for maintenance, training, storage, and administrative areas, including an Aviation Operations Support Building and Aviation Hangar. Also, it includes pavement for vehicle parking, rigid and flexible paving for aircraft parking/tie down pads, aviation lighting, utility system connections, back-up generator and fencing. This project also includes the demolition of existing facilities.

Justification: The project was solicited three times. Initially, it was solicited as a Small Business Set Aside and bids exceeded \$40 million. The project design was then adjusted using value engineering and solicited under open competition and bids exceeded \$38 million. Finally, the scope was reduced by 8,385 SF (12.5 percent). The project was redesigned and solicited under open competition. No single functional area was reduced in scope by more than 25 percent. The redesign provides a facility that meets the full intent of the congressionally approved project and provides a complete and usable facility. The scope removed will be considered for inclusion in the future phase of the project.

The project amount (PA) was calculated when the bidding climate for construction was extremely favorable and significant bid savings were being realized. Also, the PA was impacted by both sequestration and a rescission in FY 2013.

The 10 U.S.C. §2853 cost increase notification was sent to the congressional committees on April 23, 2014, reflecting a current working estimate (CWE) of \$35.1 million.
