This reprogramming action transfers \$226.9 million from the funding appropriated in section 9018 of Title IX Overseas Contingency Operations (OCO), division C of Public Law 114-113, the Department of Defense (DoD) Appropriations Act, 2016, to various Defense appropriations for execution in FY 2016. The reprogramming improves the Intelligence, Surveillance, and Reconnaissance (ISR) capabilities of the DoD by addressing Combatant Command ISR gaps. The requests meet all administrative and legal requirements, and none of these items have previously been denied by the Congress. Some adjustments in this reprogramming impact the **Military Intelligence Program (MIP)**.

<u>Part I</u> of this reprogramming transfers \$119.5 million from the Operation and Maintenance, Defense-Wide, 16/16, appropriation to various Components' FY 2016 Title IX OCO appropriations. This reprogramming action uses \$119.5 million of special transfer authority pursuant to section 9018 of Title IX OCO of division C of Public Law 114-113, the DoD Appropriations Act, 2016.

<u>Part II</u> of this reprogramming transfers \$107.4 million from the Operation and Maintenance, Defense-Wide, 16/16, appropriation to various Components' FY 2016 Title IX OCO appropriations. This reprogramming action uses \$107.4 million of special transfer authority pursuant to sections 9002 and 9018 of Title IX OCO of division C of Public Law 114-113, the DoD Appropriations Act, 2016.
