This reprogramming action transfers \$117.210 million from the Counterterrorism Partnerships Fund (CTPF), 16/17, appropriation to the Operation and Maintenance, Defense-Wide, 16/16, appropriation to provide support and assistance to foreign security forces to conduct counterterrorism activities as authorized by section 2282 of title 10, United States Code (Authority to Build the Capacity of Foreign Security Forces). This transfer is pursuant to the authority provided in Title IX, Overseas Contingency Operations (OCO), under the heading "Counterterrorism Partnerships Fund" of division C of Public Law 114-113, the Department of Defense (DoD) Appropriations Act, 2016, and section 1534 of Public Law 113-291, the Carl Levin and Howard P. "Buck" McKeon National Defense Authorization Act for Fiscal Year (FY) 2015. This action is determined to be necessary in the national interest. This reprogramming action meets all administrative and legal requirements, and none of the items have been previously denied by the Congress.

Explanation: Funds are required to provide support and assistance to foreign security forces in the U.S. Central Command area of responsibility to conduct counterterrorism activities under the Authority to Build the Capacity of Foreign Security Forces (10 USC 2282). This reprogramming action funds rotary-wing lift for quick reaction force transportation in support of Jordan counterterrorism operations. This is an OCO budget requirement.
