This reprogramming action transfers funds between and within appropriations for proper execution. The reclassification is required to execute funds properly in accordance with congressional intent. These funds are transferred pursuant to Public Law 114-254, Further Continuing and Security Assistance Appropriations Act, 2017, and section 8053 of division C of Public Law 114-113, the Department of Defense (DoD) Appropriations Act, 2016.
