This reprogramming action transfers funds between appropriations for proper execution. The reclassification is required to execute funds properly in accordance with congressional intent. This reprogramming action transfers \$6.124 million from the Operation and Maintenance, Defense-Wide, 20/20, appropriation to the Services' Military Personnel, 20/20, appropriations for the Department's Innovative Readiness Training (IRT) Civil Military Programs. These funds are transferred pursuant to section 8054 of division A of Public Law 116-93, the Department of Defense (DoD) Appropriations Act, 2020.
