This reprogramming action transfers \$23.988 million from the Drug Interdiction and Counter-Drug Activities, Defense, 20/20, appropriation to various Components' appropriations, for Overseas Contingency Operations (OCO) related drug interdiction and counter-drug activities consistent with the provisions in division A, Title IX, Public Law 116-93, Department of Defense Appropriations Act, 2020.

Realignment of funds between Drug Interdiction projects may be accomplished only with the concurrence of the Office of the Deputy Assistant Secretary of Defense, Counternarcotics and Global Threats. No funds made available in this reprogramming action may be obligated for projects pursuant to sections 321, 322, and 333 of Title 10, United States Code. This reprogramming action does not impact the Military Intelligence Program.
