<u>Project Description:</u> This project constructs a one-story reinforced masonry structure supporting admin and classroom spaces with multiple metal framed high-bay areas for KC-46A Maintenance Training Devices.

<u>Justification</u>: The current working estimate is \$4.8 million over the estimated amount. The project was solicited twice due to a lack of competition. Both times only a few bids were received with similar project costs. The cost of materials was higher than expected as a result of other competing work in the region. Similarly, the limited availability of sub-contractors has resulted in increased prime contractor's costs.

A Title 10 USC §2853 cost variation notification was not required for this project.
