This reprogramming action uses \$9.741 million of general transfer authority pursuant to sections 8005 of division A of Public Law 116-93, the Department of Defense (DoD) Appropriations Act, 2020 and section 1001 of Public Law 116-92, the National Defense Authorization Act for FY 2020. These funds are realigned pursuant to section 8021 of that Appropriations Act for authorized payments under section 504 of the Indian Financing Act.
