This prior approval reprogramming action is submitted for approval because these actions use general or special transfer authority, exceeds established reprogramming thresholds, affects special interest items, or indicates a new start. This reprogramming action provides funding in support of higher priority items, based on unforeseen military requirements, than those for which originally appropriated; and are determined to be necessary in the national interest. This reprogramming action transfers or realigns \$94.4 million between Fiscal Year (FY) 2021 Navy appropriations. This reprogramming action uses \$50.675 million of general transfer authority pursuant to section 8005 of division C of Public Law 116-260, the Department of Defense (DoD) Appropriations Act, 2021; and section 1001 of Public Law 116-283, the William M. (Mac) Thornberry National Defense Authorization Act for FY 2021.

- \$+18.4 million to support Navy O365 Sustainment (160,000 NEO365 users and 184,000 CVR Users). Additional funding is provided for the sustainment of current users on O365, and for critical Commercial Virtual Remote (CVR) capability. This increase enables the Department to: 1) continue migration of current users to Navy's secure (IL5), permanent O365 capability; and 2) execute required sustainment activities for users that have been migrated to O365. Without additional funding, the current workforce will not be on the same collaborative tools/platform and further delays will create additional future IT costs to migrate/sustain users. This is a base budget requirement.
- \$+15.325 million required for Microsoft Licenses and Baseline Cloud Security. This includes
  Microsoft Enterprise Mobility and Security E5, O365 Advance Threat Protection licenses, and Azure
  Sentinel to support Fleet Cyber Command PLANORD security posture. The licensing aligns with the
  latest DoD policy and U.S. Cyber Command security licensing. Without this funding, end user
