**PART I** transfers \$20.086 million of previously transferred Counter-drug Activities from various components' Fiscal Year (FY) 2022 appropriations for drug interdiction and Counter-Narcotics Support, back to the Drug Interdiction and Counter-drug Activities, Defense, 22/22, appropriation, consistent with the provisions in the FY 2022 Department of Defense Appropriations Act, (P.L. 117-103).

**PART II** transfers \$20.089 million from the Drug Interdiction and Counter-Drug Activities, Defense, 22/22, appropriation to various Components' appropriations, for drug interdiction and counter-drug activities consistent with the provisions in the FY 2022 Department of Defense Appropriations Act, (P.L. 117-103).

Realignment of funds between Drug Interdiction projects may only be accomplished with the concurrence of the Office of the Deputy Assistant Secretary of Defense, Counternarcotics and Global Threats. Realignment of funds between Drug Demand Reduction Program projects may only be accomplished with the concurrence of Office of the Executive Director for Force Resiliency, Under Secretary of Defense (Personnel and Readiness). No funds made available in the reprogramming action may be obligated for projects or activities pursuant to sections 321, 322, or 333 of Title 10, United States Code. This reprogramming action impacts the **Military Intelligence Program (MIP)**.
