This reprogramming action transfers funds between appropriations for proper execution. The reclassification is required to execute funds properly in accordance with congressional intent. This reprogramming action meets all administrative and legal requirements, and none of the items have been previously denied by the Congress.

This reprogramming action transfers \$2,118.439 million from the Shipbuilding and Conversion, Navy, 23/27, appropriation into the National Sea-Based Deterrence Fund, 23/27, appropriation for proper execution. The funds are appropriated by the Continuing Appropriations Act, 2023, division A of Public Law 117-180, and are transferred pursuant to subsection (d) of 10 United States Code section 2218a.
