Project originally funded in FY 2019 for \$31.0 million but was deferred to support section 2808 border barrier projects. Project funding was restored in FY 2021 for \$31.0 million based on cost estimates at the time.

<u>Project Description</u>: This project will construct a Mission Training Complex which includes a battle command training center, entry control facility and Tactical Operations Center (TOC) pads. This facility supports individual and collective digital and battle staff training utilizing constructive simulations with Command, Control, Communications, Computers and Intelligence Interoperability (C4I).

<u>Justification</u>: This project requires an additional \$17.2 million to award the authorized scope and construct a complete and usable facility. The cost increase is due to a project delay of three (3) years.

The project was initially planned for award in June 2019. Project delays and cost increases were impacted by updated Host Nation new building energy efficiency requirements as well as further inflationary costs impacted by the COVID pandemic, the war in the Ukraine and subsequent supply chain as well as fuel issues.

The project requires additional funding to address the needed scope increases for fire egress requirements, where were authorized in the FY 2023 National Defense Authorization Act. .

A 10 U.S.C. §2853 cost variation notification dated June 29, 2023, was submitted to the congressional committees.

<u>Project Description</u>: Constructs a fire station that includes an alarm communication center, high bays, equipment maintenance areas, administrative and training areas, living quarters, kitchen, dining and recreational areas.

Justification: The requirement for additional funding is attributable to the following:

- Execution Delay: Funding for this project was diverted to support an emergency construction requirement authorized pursuant to 10 U.S.C. § 2808. Project funds were restored in July 2021 but construction was further delayed due to a required real estate transfer between the privatized housing partner and the Department of the Navy for a portion of the project site.
- O Price Escalation: During the delay period the construction industry and economy experienced historically high inflation, supply chain disruption, and labor market shortages causing significant price escalation. These impacts were exacerbated by a \$2.5 billion construction program for the various U.S. Marine Corps installations in the region to recover from the impact of Hurricane Florence, creating additional premiums on both labor and material prices.

<u>Project Description</u>: Construct a 33,812 SF National Guard Readiness Center that supports training, administrative, and logistical requirements for the Colorado Army Reserve National Guard. Construction will include all utility services, information systems, fire detection and alarm systems, roads, walks, curbs, gutters, storm drainage, parking areas, and site improvements.

<u>Justification</u>: This project was bid under full and open competition in FY22 during the COVID out-break. The project cost increase is due to significant escalation in prices for construction materials and diesel fuel resulting from supply chain disruptions and extraordinary price inflation in the general economy. In this uncertain market, contractors have also had to increase contingencies in their bids to mitigate additional potential cost increases.

A 10 U.S.C. §2853 cost variation notification dated July 21, 2023, was submitted to the congressional committees.
