This reprogramming action transfers funds between appropriations for proper execution. The reclassification is required to execute funds properly in accordance with congressional intent. This reprogramming action transfers \$47 million from the Operation and Maintenance, Defense-Wide, 24/24, appropriation to the Military Departments for continued implementation and expansion of the Sexual Assault Special Victims' Counsel Program and Special Victims Investigation and Prosecution Capability, in accordance with section 8131 of division A of Public Law 118-47, Department of Defense Appropriations Act, 2024.
