This reprogramming action realigns funds between Budget Line Items within the same appropriation for proper execution. The reprogramming is required to execute funds properly in accordance with congressional intent and is determined to be necessary in the national interest. These actions do not change the purpose for which the funds were originally appropriated. This reprogramming action meets all administrative and legal requirements, and none of the items has been previously denied by the Congress.

PART I of this reprogramming action realigns \$4.539 million within the Procurement of Ammunition, Navy and Marine Corps 25/27, appropriation. This funding was previously transferred to that account pursuant to Ukraine Replacement Transfer Fund Tranche #27 (FY 25-04 IR) from the funding appropriated for Operation and Maintenance, Defense-Wide, 24/25, in division B of Public Law 118-50, the Ukraine Security Supplemental Appropriations Act, 2024.

PART II of this reprogramming action realigns \$2.387 million within the Procurement of Ammunition, Navy and Marine Corps 24/26, appropriation. This funding was previously transferred to that account pursuant to Ukraine Replacement Transfer Fund Tranche #26 (FY 24-65 IR) from the funding appropriated for Operation and Maintenance, Defense-Wide, 24/25, in division B of Public Law 118-50, the Ukraine Security Supplemental Appropriations Act, 2024.
