MEMORANDUM FOR RECORD

SUBJECT: Clothing Monetary Allowances (CMA) Rates Missing from Department of Defense (DoD) Financial Management Regulation (FMR) Volume 7A, Chapter 29 Archives

The purpose of this Memorandum For Record (MFR) is to identify the CMA rates that were not recorded in archived versions of the Volume 7A, Chapter 29. During the normal update process for DoD FMR Volume 7A, Chapter 29, it was discovered that the following CMA rate changes were missing from the archives:

- Mid Year Change Effective April 1, 2016 Navy
- Mid Year Change Effective April 1, 2017 Navy
- Mid Year Change Effective May 30, 2017 Navy
- Annual Change Effective October 1, 2018 All Services
- Mid Year Change Effective April 1, 2019 Navy and Air Force

Once a chapter is reissued, the previous version is archived and is no longer available for additional update. This MFR ensures the correct CMA rates are available for historical purposes.

Attachments 1-5 show each affected table and the CMA rate changes. Each table is structured in the same manner as the current Volume 7A, Chapter 29. The changes are in blue font and include applicable notes, and are in sequential order.



It is payable to recruiters after reporting to the enlisted Navy Recruiter Orientation Course or upon completion of the Veteran Recruiter Orientation. It is payable to recruiting support personnel upon receipt of orders to such duty. It is payable to members in BUPERS controlled recruiting billets or a recruit support billet upon initial assignment, when specialized training is not required prior to the recruiting assignment.
