

FOOD SERVICE CHARGES AT APPROPRIATED FUND DINING FACILITIES
FISCAL YEAR 1999

Chapter 19, "Food Service Program," of Volume 12, "Special Accounts, Funds and Programs," of DoD 7000.14-R, DoD Financial Management Regulation, provides that the Office of the Under Secretary of Defense (Comptroller) shall prescribe, annually, rates to be charged for meals at DoD appropriated fund dining facilities. Food Service Rates for FY 1999, effective October 1, 1998, are shown below:

A. Traditional Meal System

B. A la Carte Meal Pricing System - When using an "a la carte" menu, the price of each item on the menu should be established at 133 percent of the food cost (i.e., the cost of the raw food multiplied by a factor of 1.33).

^{1/} Includes spouses and other dependents of enlisted personnel in Grades E-1 through E-4.

^{2/} Includes members of organized nonprofit youth groups sponsored at either the national or local level and permitted to eat in the general dining facility by the Commanding Officer of the installation.

^{3/} Includes officers and federal civilian employees who are not receiving the meal portion of per diem, and who are either:

- a. Performing duty on a U.S. Government vessel,
- b. On field duty,
- c. In a group travel status, or
- d. Included in essential unit messing (EUM) as defined in the JFTR, Volume 1.

^{4/} Includes officers, enlisted members, and federal civilian employees who are not receiving the meal portion of per diem, and who are on a U.S. Government aircraft on official duty either as a passenger or as a crew member engaged in flight operations.

^{5/} Includes officers, enlisted members, and federal employees on Joint Task Force operations other than training at temporary U.S. installations, or using temporary dining facilities.

^{6/} Includes any officer, enlisted member or federal civilian employee receiving the subsistence portion of per diem, all officers and enlisted members receiving an allowance for subsistence (other than those addressed in Footnotes ^{3/}, ^{4/} and ^{5/} above), and all other personnel (including Reserve Component officers on Inactive Duty Training) authorized to eat in DoD appropriated fund dining facilities.

^{7/} Use breakfast or dinner rates based on whether the breakfast or dinner menu is served.
